- The number of sections in the school are restricted to 30 as per number of sections reported by the IC and shall not be increased without specific approval of the Board. For increase in number of sections, the School shall 9. apply online to the Board as per rule 15.7 of affiliation bye laws.

- Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters. 15
- The Manager and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/ information/data submitted by the School to the Board.
- Apart from rules to be adhered to by the school as mentioned above for drawing specific attention of the school 16. authorities, the school authorities are required to acquaint themselves with all the rules contained in Affiliation & Examination Bye-laws and circulars/guidelines/ notification issued by the Board from time to time.
